I am writing on behalf of Mr. Geoffrey David Mead (Mr. Mead) who referred to me a video you have posted on August 15, 2021 in your Youtube Channel: A Foreigner Farming in the Philippines.

You titled the video: "GD Mead Is A Criminal" with 1, 976 views. In the video you explained how Mr. Mead is a criminal and the crimes he have allegedly committed, but you have said it yourself that he has not been convicted of any crime as shown by the transcript below:

Your act of posting the libelous video in your youtube channel with almost 2, 000 views have caused dishonor and contempt to Mr. Mead which violates the Philippine Law on Cyber Libel.

Section 4(c)(4) of the Cybercrime Prevention Act of 2012, which punishes the crime of cyber libel, makes reference to Article 355 of the Revised Penal Code:

"(4) Libel. – The unlawful or prohibited acts of libel as defined in Art. 355 of the Revised Penal Code, as amended, committed through a computer system or any other similar means which may be devised in the future."

The Revised Penal Code provisions on libel read:

Art. 353. Definition of libel. — A libel is public and malicious imputation of a crime, or of a vice or defect, real or imaginary, or any act, omission, condition, status, or circumstance tending to cause the dishonor, discredit, or contempt of a natural or juridical person, or to blacken the memory of one who is dead.

From the definition of libel under Article 353 of the Revised Penal Code, **Cyber Libel is defined as a public and malicious imputation of a crime, or of a vice or defect, real or imaginary, or any act, omission, condition, status, or circumstance tending to cause the dishonor, discredit, or contempt of a natural or juridical person, or to blacken the memory of one who is dead, and committed through a computer system or any other similar means which may be devised in the future.**

The crime of cyber libel is punishable by imprisonment ranging from 2 years to 8 years plus damages.

In this regard, you hereby advised to remove the video: GD Mead Is A Criminal and desist from making/posting similar video intended to malign Mr. Mead. Or else, I will have to take legal action to protect Mr. Mead's interest.

I trust that you will give this matter your prompt and preferential attention.
